- GIVEN** the Regulations for the Administration, Finance and Accounting of the University of Camerino, approved by Rector Decree No. 475 dated 12 November 2013, and in particular the article No. 109 of it;
- GIVEN** the Resolution No. 67 of 16 March 2016 of the School of Medicinal and Health Product Sciences;
- GIVEN** the minutes of the University of Camerino Master Commission of 23 May 2016;
- GIVEN** the resolutions of the Academic Senate No. 28 of 31 May 2016
- GIVEN** the Decree of the Rector No. 162 of 31 May 2016 for the activation of the UNICAM Master programs, for the academic year 2016/17;
- GIVEN** the minutes of the Scientific Council of the Master in Aesthetic Medicine and Therapeutics University of Camerino Master Commission of 30 March 2016;
- CONSIDERED** the need of establishing teaching contracts for the Master in Aesthetic Medicine and Therapeutics for stage activities in Athens (Greece);

**Call Purposes**

This selection is aimed at drawing up a ranking for teaching assignments of modules listed below. The ranking will be based on the possession of the best criteria for covering the courses listed below. The ranking will apply to the edition of the Master for the academic year 2016-2017 and for the next one in case of activation of another edition of the Master.

The compensations indicated above should be intended as gross amounts, inclusive of all charges also covered by the university or of the individual.

### Hiring criteria

#### *Requirements*

- a. Possession of enough qualification for covering chosen teaching activity at the time of appointment;
- b. Documented experience in the field concerned at an international level;
- c. Ability to provide educations in English;
- d. Ability/availability of performing a relevant part of educational activity via e-learning;
- e. Keen interest in conducting the education outlined in the above section (teaching responsibilities/Program of studies)
- f. Ability to perform educational works closely communicating and smoothly cooperating with the University of Camerino staff of the Master

#### *Evaluation of applications*

Applications in response to this call will be selected by the Scientific Council of the Master which will draw a ranking based on the above requirements and using the objective criteria listed below. This ranking (indicating the winning candidate, other participants in the selection procedure and not suitable candidates) will be published on the University of Camerino WEB site and posted in the roll of the School. The Scientific Council of the Master will reserve to himself the right to use the ranking list of the present call to meet similar needs, or do not use it if collaboration will be no longer necessary and/or convenient.

First applications submitted by employees of the University of Camerino will be examined. Subsequently, in the absence of applications from employees of the University of Camerino, or in case these applicants would be judged not suitable or lacking suitable candidates, applications submitted from outside the University of Camerino will be evaluated.

#### *Criteria for evaluation of applications*

For the comparative evaluation of applications received, the Master Scientific Council of the Master will have 100 points for each candidate distributable between the titles listed below. The declaration of suitability of candidates could depend on the achievement of a minimum score established by the Scientific Council.

- a. Qualifications (eg. Degree, PhD, specialization);
- b. Attendance of specific qualifications courses related to the discipline for which the candidate is competing;
- c. Previous experience teaching in the same Master or in related Master with positive evaluation results, when available, from the participants;
- d. Teaching experience in disciplines related to those of the present call by Faculty staff of foreign universities;
- e. Research activities documented at public and / or private institutions;
- f. Publications and other scientific and academic degrees;

#### **Contract of collaboration**

The administrative Offices of the University of Camerino will propose to the winner candidates a contract for the provision of professional services of this call. This contract will govern the various organization and taxes aspects of the service provided, including possible penalties for failure or delay in executing and/or performing assigned duties.

The contract will cover the time between 4 May 2017 to 31 October 2017. The contracts could be renewable if necessary, for justified reasons, after a further formal contractual agreement between the parties. Working relationships are under the frame of contracts for work regulated by the article No. 2222 of the Italian Civil Code as indicated by the article No. 7 of Legislative Decree No. 165/2001.

**According to the 2008 Budget law, Italian citizens or residents winners of the selection and possessors of VAT should provide invoicing for payment of the compensations of this call exclusively via electronic means (FatturaPA format. This format is the only one accepted by the Exchange System, Ministerial Decree provided for by the law of 3 April 2013, No. 55).**

#### **Applications**

Applications addressed to the Director of the Master of the International Master in Aesthetic Medicine and Therapeutics should be filled-in using the template enclosed. The following documents must be sent with the application:

- a. signed application form;
- b. copy of a valid identification document;

- c. curriculum vitae in European format;
- d. other documents and certificates useful for the selection.

The Scientific Council of the Master can subordinate the signature of the contract of collaboration to the original presentation of the titles that the candidate has declared to possess. Employees of Italian public administrations winners of this selection, before signing the contract should require and obtain the authorization from their own administration to make teaching activity of the present call.

**Handling of personal data**

Personal data transmitted by the candidates applying for the selection will be used for institutional purposes and in compliance with the European and Italian legislation on protection of personal data (Legislative Decree 196/2003, <http://194.242.234.211/documents/10160/2012405/Personal+Data+Protection+Code++Legislat.+Decree+no.196+of+30+June+2003.pdf>). This legislation is based on principles of fairness, lawfulness, transparency and is aimed at protecting fundamental rights and freedoms of citizens. These data will be processed, including by the use of electronic means, by the Director of the Master or those specifically charged for managing administrative procedures and for fulfilling legal obligations. The provision of personal data is optional but a refusal makes it impossible to proceed with contract completion.
