Art. 1 - GOALS AND OBJECTIVES

Recently, aesthetic medicine and in particular, regenerative medicine, a biological branch that involves all medical specialties both in terms of the regeneration of individual tissues and systemic regeneration, has become a significant reality in both the medical and social fields. The culture of well-being medicine, useful for optimizing the patient's psychophysical functions, much felt in the societies of the industrialized West, presents the risk of being satisfied through inadequate and superficial information that, at times, leads to ineffective or even harmful "do-it-yourself" remedies.

In this context, a qualified university education, with excellence in the field, operating at the national and international level, is a guarantee for users. In addition, it is a quality response to which a public university must respond. The Master's program in Aesthetic and Regenerative Medicine, co-organized by Camerino and Turin Universities, aims to provide graduates in Medicine and Surgery or Dentistry, members of their respective Registers, with theoretical and practical training relevant to the practice of aesthetic and regenerative medicine. There are no institutionally recognized specialized figures in

¹ IMPORTANT NOTE. Throughout the whole call text, when you read "Master" or "Master course" we mean "Corso di Master Universitario di secondo livello". "Corsi di master universitario di secondo livello" are 3rd cycle programmes intended to provide students with further specialization or higher continuing education studies after completion of the second cycle. Access is by a "Laurea Magistrale" degree (or a comparable foreign degree); admission may be subject to additional requirements. Studies last at least 1 year (60 ECTS/CFU credits). The qualification awarded (Master Universitario di secondo livello) does not give access to "Corsi di Dottorato di Ricerca" or to any other 3rd cycle programmes, since this type of course does not belong to the general requirements established at national level, but it is offered under the autonomous responsibility of each university.





the field of aesthetic and regenerative medicine, and it's aimed at those without pathologies who need to improve their appearance and eliminate imperfections. It is important that personalized treatments like aesthetic medicine and regenerative medicine, are based on adequate patient selection, and that diagnostic and treatment techniques are learned. A special focus should be placed on preventing and resolving any complications that may arise.

Master students will have the opportunity to take part in theoretical training through the use of information and communication technologies (ICT). By doing so, participants who are already professionally engaged will be able to attend the Master's program. The face-to-face training will take place in Cologne (Germany). In the practical part of the training, activities will be planned for single attendants in collaboration with the University of Camerino (UNICAM) and Turin, and take place at Cologne (Germany), at Praxis Hardung (Alarichstrasse 53, 50679, Cologne, Germany) accredited facilities located in areas that can be easily reached by Masters' attendees.

Art. 2 - PROFESSIONAL PROFILE

The Master's program is designed for doctors with different training paths in medicine and surgery, or dentistry. This Master aims to provide a high-level training program to professionals interested in learning about the theoretical and practical bases of nonsurgical treatment of imperfections with a complete knowledge of regenerative medicine. Learning regenerative medicine methods and protocols will allow better functioning of all the organs of our body, improving the quality of life of patients and slowing down the aging processes. These include scars, skin laxity, wrinkles, stains, excessive fat, cellulite, unwanted hair, discoloration of the skin, varicose veins, and cc. Master program is designed to meet the requirements of graduates already engaged in the workplace, so advanced ICT tools will be used to develop a portion of the theoretical training. A program of frontal and practical activities will take place in intensive stages at Praxis Hardung (Alarichstrasse 53, 50679, Cologne, Germany).

A Cadaver Lab workshop will be organized for Master's students at the end of their first year of studies. During the Cadaver Lab, which will be held in Turin, Master's students will be able to deepen the anatomical knowledge they learned during the Master's program, practice the injection techniques they learned, and assess and learn the areas of risk for treatment directly on a fresh anatomical specimen.

Art. 3 - OCCUPATIONAL PROSPECTS OR IMPROVEMENT OF POSITION OR ROLE

Professionals with specialized health and beauty facilities will have more opportunities to work in their own studios, multi-specialized centres, wellness centres, gyms, spas or hotel complexes, as well as companies that manufacture and develop products in the industry.

Art. 4 - TEACHING PLAN OF THE COURSE

The Teaching Plan is available in Annex 1 of this Call

Two fields are included in the Master's course:

- An Aesthetic and Regenerative Medicine course aimed at training doctors with degrees in medicine and surgery.
- Face Aesthetic and Regenerative Medicine for the training in aesthetic medicine of dentists and registered doctors-surgeons.

Both fields are part of the first year of the Master's program, which focuses mostly on theoretical training. The second year will have modules dedicated to dentists, focusing on treatments involving the





anatomical area of the face, and modules dedicated exclusively tomedical doctor, focusing on full-body aesthetic and regenerative treatments.

The course is taught in English.

Art. 5 – STRUCTURE/ORGANIZATION OF THE ACTIVITIES

- 1. Course duration: 2 Years.
- 2. According to the Forecast Plan and subject to changes that will be promptly communicated, Lessons will begin in April 2026 and will conclude by October 2027. Training activities will end with the final exam by November/December 2027.
- 3. Location:
 - -Cologne (Alarichstrasse 53, 50679, Cologne, Germany)
- 4. Training will include the following activities:
 - E-learning platform and videoconferences (for theoretical topics)
 - Face-to-face lessons
 - Practical activities
 - Cadaver lab dissection intensive practical course
 - Supporting teacher's trainer's activity

CADAVER LAB

The Cadaver lab will be built in November 2026 on a date that will be communicated during the first meeting of frontal lessons. Cadaver Lab's activity will take place in Turin.

Art. 6 - ADMISSION REQUIREMENTS

The Master is open to applicants graduated in:

- 1. Medicine and Surgery
- 2. Dentistry

To apply, applicants must be registered on the appropriate registries of medical practitioners and dentists. To register with the Master, proof of registration status must be provided. This course is offered in English. It is therefore necessary to have a good understanding of the English language in order to attend the Master course. Students must have computer and Internet skills in order to follow





courses in the mode and interactive e-learning, and a multimedia PC with broadband connection for the ICT interactive activities.

Art. 7 - CANDIDATES GRADUATED OUTSIDE ITALY

Candidates who have earned a degree outside of the national territory that is comparable in level, nature, content, and academic rights to the Italian degree required for admission to the course may apply for registration. For information regarding access to the course for foreign citizens and community holders of foreign academic qualifications, please refer to the Italian Ministry of University and Research's website: universitaly.it/studenti-stranieri

- 1. Applicants with foreign academic qualifications that are comparable in level, nature, content and academic rights (access to further courses), to the Italian academic title required for access to this Master, are eligible to enroll. Registration remains subject to assessment of eligibility. It is necessary for applicants to meet professional qualification requirements. In compliance with the Lisbon Convention, qualifications issued by international authorities must include the documents indicated below. The student/applicant is required to provide the documentation that the University considers acquiring for evaluating the foreign qualification. These include translations, legalizations, Diploma Supplements, certificates given by the Italian ENIC-NARIC centre (CIMEA), and any Declarations of Value. Candidates holding a certificate of comparability of a foreign qualification (CIMEA) are exempt from submitting the Declaration of Value. Candidates who are non-EU citizens living abroad should submit their registration application directly to the University of Camerino through the portal UNIVERSITALY, in accordance with the terms and conditions of the Call. In order to apply for these training activities and courses, applicants must use the UNIVERSITALY portal.
- 2. Through the UNIVERSITALY portal, candidates can apply directly to the University of Camerino for the Master's program in Aesthetic Medicine and Therapeutics. This call is conducted in accordance with the procedures and terms set forth. Upon admission/matriculation, candidates must present their qualifications, along with their documents required for admission or matriculation. The Italian diplomatic authority in the candidate's country should be contacted once the university has confirmed the acceptance of the candidate. The validity of this visa is determined by the duration of the course.
- 3. Registration and matriculation remain subject to evaluation by the University of Camerino in the following areas:
 - Evaluation by the technical-administrative structure of the University's Central Administration;
 - The contents of the Master's program will be determined by the Scientific Council of the program according to the skills acquired.

Art. 8 - NUMBER OF ATTENDANTS PER CLASS

1. The course has a limited enrollment. The minimum enrollment for activation is 25 students and the maximum number of students is 40.





- 2. Upon exceeding 40 applications, a new Master class will be activated. It is necessary to receive at least 20 requests for admission in order to activate a new class. It will be communicated to applicants that this opportunity is available as well as the deadlines for applying to the new class.
- 3. In the event that the minimum number of students is not reached, the course cannot be activated.
- 4. Registration deadline:
 - First Cologne class deadline: 30 April 2026

Art. 9- ATTENDANCE REQUIREMENTS

To be admitted to the final examination, students are required to have attended at least 75% of the annual activities.

Art. 10 - TERMS AND MODALITIES OF ADMISSION

- 1 Applicants must receive a favourable evaluation of their curriculum vitae of studies from the Course's Scientific Council in order to be admitted to the Master's program.
- 2 An e-mail will be sent to each candidate within five days of the application deadline informing them of the results of their application.

Art. 11 - APPLICATIONS TERMS AND MODALITIES

1. Applications form should be sent online by the 30 April 2026 latest (Article 8). Information and news about the application process, as well as possible modifications to the document of the competitive selection can be found at http://www.unicam.it/miiscrivo.

The following documents must be attached by students who obtained their qualifications outside of Italy and must be send for enrollment to the email medicina.estetica@unicam.it and info@masterinaesthetics.de:

- Original degree certificate translated to english and legalized;
- Application form;
- Passport;
- Proof of payment of 1st Installation of 500 €. The bank transfer receipt must be sent, along
 with all the required registration documents to the Master's secretariat email address

- Required no later than the first semester of the second year of the Master's course: Certificate of Verification and Compatibility which can be obtained through the request procedure to be submitted online, from the website www.cimea.it under the heading "certificates of comparability and verification of qualifications". This certificate must be sent to the master's secretariat (medicina.estetica@unicam.it) no later than the first semester of the second year of the Master's course or Dichiarazione Di Valore (Declaration of Value) issue by Italian Consulate, is a document of an informative nature that describes the foreign qualification in question and provides every useful piece of information to allow the relevant Italian authorities to evaluate the qualification itself for the purposes of its recognition in Italy or Diploma Supplement.





Art. 12 - REVOCATION, SUSPENSION OR WITHDRAWAL

- 1. In the event that an attendee does not meet the minimum attendance requirements laid out in the course, their status will be revoked.
- 2. Attendants who fail to obtain the title by the end of the enrolment year cease to be students. In exceptional circumstances, the scientific council may arrange for a second session before the end of the academic year of reference
- 3. A failure to pay the second instalment within 30 days of the due date will automatically result in registration. The result of this will be the loss of the right to participate in the activities described in the course's teaching plan and to obtain the degree.
- 4. It is not possible to accept frequency obligations that have been suspended. The suspension of training may only be granted in cases of prolonged illnesses (which exceeds the maximum percentage of absence), pregnancy, or maternity/paternity (at the request of the individual concerned). During this period, it may be possible to obtain admission in excess of the edition in the academic year immediately following, provided that the course is reedited.
- 5. It is possible for attendees to stop their attendance at the Master at any time by submitting a request. The waiver results in the loss of the attendant status. The student is not entitled to receive a refund of any fees paid at the time of the waiver.

Art. 13 - REGISTRATION FEES

1. A full fee of 6.000 € per year (and a total of 12.000 € for the two years),² is required to be paid as follows:

Confirmation fee: 500 € upon completion of the Master's registration. The bank transfer receipt must be sent, along with all the required registration documents indicated in Article 11, paragraph 4, to the Master's secretariat at the official email address medicina.estetica@unicam.it

1st Instalment: 1.500 € upon commencement of the Master's teaching activities, which will be communicated in advance by the Master's secretariat.

2nd Instalment: 2.000 € within 30 August 2026.

3rd Instalment: 2.000 € within 30 October 2026. **4th Instalment**: 2.000 € within 28 February 2027. **5th Instalment**: 2.000 € within 30 July 2027.

6th Instalment: 2.000 € within 30 September 2027.

2. Transfers of funds made from abroad must indicate the reason, the name of the student and the title of the Master and must be made to the following account:

² The fee includes: payment of the regional tax for the first and the second year (€ 140,00 for each year), n.1 revenue stamp for registration (€ 16,00), n. 1 stamp duty for the parchment (€ 16,00).

Art. 15 – FINAL EXAM AND AWARDING OF THE TITLE

- 1. At the end of the course, only students who: have fulfilled the required learning requirements; have attended at least 75% of the course (of the total number of hours); have completed the online course evaluation questionnaire available on the University website by connecting to the link http://survey2.cs.unicam.it/limesurvey/index.php/259481?lang=it; will be able to take the final exam, which will take place in the following ways:
 - Written test
 - Oral test
 - Discussion of Thesis (PPT)
- 2. Intermediate examinations for each module as well as the results of the final tests at the end of each year will be ranked in 30/30. The final test results with a score based on 110/110.
- 3. After successfully completing the final exam and the course evaluation questionnaire, the Universities of Camerino and Turin, jointly, will issue a "Diploma di master internazionale universitario di secondo livello".

Art. 16 -PERSONAL DATA

1. The personal data provided by candidates and members with the application form will be processed in compliance with the principles set forth in Legislative Decree no. 196 of 30 June 2003, "Personal Data Protection Code," and the GDPR (EU Regulation 2016/679).
