1. GENERAL INFORMATION

1.1 Purpose

Erasmus+ is the 2021-2027 EU Programme supporting education, training, youth and sport created by the European Parliament.

The Erasmus+ Programme, in particular the KEY ACTION 1(KA131) – MOBILITY OF INDIVIDUALS, supports the students' mobility to help them undertake their learning experience (Mobility for Study and Mobility for Traineeship) in another country.

The Erasmus+ Programme enables students to get acquainted with new higher education methods, to meet young people of foreign countries and to experience culture abroad, by making them to actively participate in the European integration process. This way, the Erasmus+ Programme manages to consolidate the students' mutual relationships and to strengthen the academic and cultural dialogue, by promoting a sustainable development thanks to a mutual exchange of knowledge, with a view to promoting the European values and culture worldwide.

The University of Camerino continues to support the students' international mobility for the 2025-2026 academic year with the publication of this call for applications governing the Mobility for Study.

Students may spend a continuative period of study (from 2 to 12 months) at a European University (KA103) that signed an Inter-institutional Agreement with the University of Camerino within the framework of the Erasmus+ Programme (*Annex 1 – Table of Agreements*).

The Erasmus+ Programme allows for **short-term mobility** from 5 to 30 days with a mandatory virtual component (that precedes or follows the physical one) for 1st and 2nd cycle students and that must be agreed upon in advance and towards the locations described in Annex 1.

For doctoral students, however, the virtual part is not mandatory.

Short-term mobility will be regulated by additional calls.

1.2 EU countries participating in the Erasmus+ Programme

- The EU Member States: Austria, Belgium, Bulgaria, Cyprus, Croatia, Denmark, Estonia, Finland, France, Germany, Greece, Ireland, Latvia, Lithuania, Luxembourg, Malta, The Netherlands, Poland, Portugal, Czech Republic, Romania, Slovakia, Slovenia, Spain, Sweden and Hungary.
- the 3 countries of the European Economic Area (EEA): Iceland, Liechtenstein and Norway.
- the EU enlargement candidate countries: the former Yugoslav Republic of Macedonia, Serbia and Turkey.

1.3 Mobility towards UK and Switzerland (Partner Countries)

Mobility towards the United Kingdom and Switzerland is also guaranteed; the contribution is covered by community funds equal to those envisaged for the Program Countries of GROUP 1 (please refer to *Table 3* at page 7).

All the requirements set out in this Call related to the Program Countries will apply to exchange students for UK and Switzerland.

Students who will be selected for those destinations must consider that:

- they must comply with the entry rules established by the receiving Countries and, consequently, inquire about the entry visa and health insurance;
- visa costs, health insurance and any other costs required for entry into those countries or for acceptance by the UK office will not be covered by UNICAM.

The destinations for the United Kingdom and Switzerland are reserved to the students of the degree courses specified in the following table:

1.4 Double Degree Mobility

By applying to this announcement, it is also possible to obtain support for spending the period of study abroad necessary to obtain the Italian qualification and the foreign qualification, for study courses that provide this possibility. The conditions for participation vary depending on the foreign institutions, the year of registration, the academic requirements required and are regulated in specific agreements. Students who intend to participate in a mobility within the scope of Double Degree paths will be able to apply to this call exclusively for the following locations reserved for these paths:

1.6 Eligible activities

During mobility for study, students may carry out educational activities to achieve credits, previously agreed upon with the Delegates for International Mobility of each degree programme, as follows:

- attendance to courses (lectures) and sitting of the relating assessment tests (exams);
- preparation of the bachelor's, master's and/or PhD thesis;
- traineeship combined with a study period. Such traineeship must be carried out, with the prior authorisation of the Delegate of the Study Course/School, under the supervision of the same university where the student is due to perform his/her studies and the two activities shall be carried out consecutively.

The students participating in an Erasmus+ mobility programme will acquire the **status of “Erasmus+ students”**, that may be summed up as follows:

- Erasmus+ students are equalized to all intents and purposes to the students at the receiving university: they are admitted attending the academic programmes and to sit the relating exams, to carry out research for their thesis, to be admitted to libraries and labs, to attend traineeships or stages (wherever there are specific conventions entered into by the receiving university), to benefit from the same services offered to their foreign colleagues.
- the tuition fees shall be paid at UNICAM according to the deadlines and modalities communicated by the same. No fees shall be paid to the receiving university (except the payment of small fees, if any, for insurance services or for the use of technical materials such as photocopies and lab products).

Upon conclusion of the mobility, the grant holders will be entitled to the full recognition of the exams taken and of the activities performed, pursuant to the Learning Agreement and according to the results and judgments recorded in the Transcript of Records.

1.7 Period and duration

The mobility period must necessarily conclude by 31 July 2027.

The duration of the mobility is established by the agreements signed with the partner universities and ranges from a minimum of 2 months (it cannot be less than 60 days) up to a maximum of 12 months.

Extensions of the period are permitted only for proven educational reasons, in any case the overall duration of the stay at the partner institution must be continuous. The motivated extension request must be sent before the end of the mobility (within 1 month from the end of the mobility) and authorized by the Erasmus+ mobility Delegate of the Study Course/School. The grant for the additional period will be awarded until available funds are exhausted.

1.8 Funding

All funding is exclusively allocated for the allowed educational activities (please refer to “*Activities to be performed during mobility and Learning Agreement*” paragraph 2.5).

The Erasmus+ funding is, moreover, linked to study and/or educational activities carried out and to their following acknowledgement by the competent body of the degree programme which beneficiaries are enrolled in.

The students who do not satisfactorily complete any activities, do not obtain any recognition of the activities carried out or do not apply to have their activities acknowledged within the date of achievement of their degree, or still who refuse the acknowledgement granted, shall return entirely or partially the amount of the funding received.

The funding for the mobility period is paid by means of funds allocated by the Erasmus+ National Agency, Ministry of University and Research and by the University of Camerino.

EUROPEAN CONTRIBUTION

The **EU contribution** is to pay part of the mobility cost related to the staying abroad. It is a contribution calculated based on the destination and the number of days performed. The contribution is modulated according to the following groups of destination:

TRAVEL SUPPORT

As set out in the 2025 Programme Guide, a travel support is provided for all mobility activities, including those involving students travelling to EU Member States, third countries associated with the Programme, and non-associated third countries in Region 14, in accordance with the rates specified in *Table 4*.

The “Distance band” refers to the distance between the place of origin and the place of destination, while the “amount” covers the travel contribution both to and from the place of destination.

ADDITIONAL FUNDING FOR PARTICIPANTS WITH FEWER OPPORTUNITIES (TOP UP)

To promote equal opportunities and access, inclusion and diversity, **an additional funding to the mobility grant**, is addressed to the needs of **participants with fewer opportunities** as follows:

- students with economic condition lower or up to €27.948,60 (to be certified by ISEE);
- students with minor sons;
- working students;
- students who are professional athletes;
- students orphaned of at least one parent;
- students' victims of terrorism or organized crime.

To receive the **additional funding** students must include in the application form a **specific declaration** in which they indicate their condition (*Annex 3*) according to the above-mentioned fewer opportunities list. The additional funding of €250/month, regardless of the country of destination, is calculated on the basis of the days of actual stay abroad. It is paid at 80% within 30 days, after the submission of the Arrival Certificate to the office, together with the payment of the European contribution.

MINISTERIAL / UNIVERSITY INTEGRATION

The Erasmus grant may be further supplemented through the MUR (Ministry of University and Research) Youth Support Fund, according to the economic conditions certified by the ISEE University indicator (Facilitated Benefits for the Right to Study), as outlined in the following table:

To maintain this integration, students must obtain recognition in credits of a training activity carried out abroad at the end of the mobility.

Those who prove to have an ISEE higher than €50,000 or who do not declare the ISEE value will still receive a university supplement equal to €100 for each month of mobility.

Not regular students who have exceeded of one year the standard term of the degree programme will be only entitled to the University integration equal to € 100 per each month of mobility.

With regards to Double Degree mobility for Albania destination, the integration of the scholarship with the ministerial or University fund is not foreseen.

Terms of payment:

The financial contribution due is initially estimated on the number of monthly payments indicated by the host University, as indicated in the acceptance letter or in the academic calendar. At the end of the Erasmus period, the financial contribution is recalculated on the actual number of mobility days carried out according to the counting methods envisaged by the Erasmus+ Programme:

The provision of:

- a **first instalment**: 80% of the integrative contribution (*Table 5*) will be paid before the beginning of the mobility.
- a **second instalment** of 80% of the Community contribution which will be paid within 30 days upon receipt of the arrival certificate.

- a **final payment** of 20% of the two contributions, calculated on the right number of the mobility days performed. It will be paid after the coming back and the submission of all the required documents and the completion of the Beneficiary Report (questionnaire).
- For students undertaking their mobility at one of KreativEU's partner institutions (<https://kreativeu.org/>), an additional contribution of €150 is provided. This amount is paid at the end of the mobility period, upon verification of the activities effectively completed.

REFUNDS AND REDUCTIONS

The contributions received are subject to the obligation of total or partial repayment in the event of:

- renounces the mobility period.
- stay shorter than the mandatory minimum period of 60 days;
- failure to complete any of the curricular activities indicated in the Learning Agreement and consequent recognition of training credits useful in one's study plan;
- reduction of the period abroad compared to what is provided for in the agreement (this entails a refund corresponding to the number of days not spent abroad).

Furthermore, those who meet the eligibility requirements for the ERDIS scholarship will be able to request the integration granted by the ERDIS Marche Presidio of Camerino for international mobility (information available on the website <http://www.erdiss.it>).

STUDENTS WITH SPECIAL NEEDS RELATED TO PHYSICAL, MENTAL OR HEALTH CONDITIONS

To allow wider participation in the Erasmus + program, an additional financial contribution is provided at the community level, subject to evaluation by the Erasmus+ National Agency. Interested students can also request specific contributions to cover special needs, which will be evaluated, from time to time, by the National Agency. For more detailed information, contact the mobility office.

1.9 Green Travel Grant

In line with the 2025 Programme Guidelines, students who choose low-emission means of travel (such as train, car sharing, bus, or bicycle) may receive an additional contribution of 50,00 euros and, where applicable, up to 6 supplementary days of individual support to cover travel time.

1.10 Insurance coverage

The Participants shall have a suitable insurance coverage.

The basic health insurance is provided by the National Health Service by means of the European Insurance Health Card (EHIC), also during their stay in another EU country.

The University of Camerino sees to the insurance coverage for the Erasmus+ students in mobility abroad with the following policies:

- Civil Third Parties Liability Policy n. 410656394, Company AXA Assicurazioni S.p.A. – Perugia: insurance against risks arising from third party liability, excluding the damages falling within professional liability;
- Accident Insurance Policy n. 3151, Company INAIL: personal accident insurance linked to the educational activity/traineeship to be carried out by the participants;
- Only in case of extra-EU mobility: Policy Inter Partner Assistance n. 100832584 (generic policy for refunding of medical expenses, accident, repatriation of deceased).

Please note: the insurance coverage of the European Insurance Health Card (EHIC) and the UNICAM insurance policies might not be sufficient, especially in case of specific medical examination and accidents that are not linked to educational activities.

Students should inquire with their host university about the specific healthcare requirements in their host country and, where necessary, purchase supplemental health, hospitalization, or repatriation insurance.

Host universities may also require other types of supplemental insurance.

Therefore, it is advisable to take out a private insurance which covers accidents unrelated to study activities. The costs and administration of these procedures are entirely borne by the student and may vary depending on the length of stay.

Foreign students who are not resident in Italy and who are voluntarily enrolled in the NHS, not being EHIC holders, will have to take out a private health policy.

2. PARTICIPATION REQUIREMENTS AND MODALITIES TO SUBMIT APPLICATIONS

2.1 General requirements for participation

1. Students who intend to apply must be regularly enrolled in one of UNICAM degree programmes.

Students of a first cycle degree who, at the time of application, are enrolled in the third year or outside the course and expect to graduate within the academic year 2025/26 can apply for mobility in the Second Cycle. The mobility period can only begin following actual enrolment in the 2026/27 academic year, coinciding with the payment of the first instalment and in any case in compliance with the deadlines established by the host University.

Students who, in the 2025-2026 academic year, are enrolled in the third year of a degree programme, may go on mobility by proposing a Learning Agreement with programmes relating to their degree only if in the 2026-2027 academic year they will be enrolled as irregular students (Fuori Corso).

In case of mobility of students who intend to graduate in the extraordinary session of April 2027 of the 2025-2026 academic year, the enrolment in such academic year shall be considered as valid. Yet, the mobility shall end in time to obtain the acknowledgement of the activity carried out and to comply with the administrative fulfilments established by the Student Office.

- 2. Only students who, in the same period, are not beneficiaries of another EU contribution provided for by other mobility programmes can apply.** At all events, it is pointed out that the Erasmus grants are compatible and cumulative with all other types of grants (i.e., ERDIS scholarship), except as otherwise provided for by the funder.
- 3. The admission of students who, in the past years, waived the Erasmus grant without any grounded reasons** will be assessed by the Evaluation Committee.
- 4. Students with citizenship of one of the countries participating in the Erasmus+ programme** are eligible for mobility at a university in their country of origin provided that they are not yet resident in that country; in any case, they will not be given priority in the selection process. They must also obtain, before being able to confirm acceptance, the authorization from the host university.

2.2 Incompatibility

Incompatibilities concern both grant and status as Erasmus student.

Students applying to Erasmus+ Mobility for Study:

- can obtain one or more Erasmus+ scholarships for each study cycle (I, II and III cycle) and for a period not exceeding 12 months per each cycle; in case of single cycles (Pharmacy-Chemistry and Pharmaceutical Technologies-Veterinary Medicine-Law), the maximum number of months is 24. Any previous mobility experiences within the framework of the Erasmus+ Programme for study or traineeship shall be included in the calculation of the months already enjoyed, so as to verify whether students have already reached or exceeded the established ceiling.

For the 2026-2027 academic year, also students who have previously enjoyed of an Erasmus+ grant for study or traineeship may apply to the Call for applications, provided that they still have an adequate period of time available to spend abroad for the study cycle for which they are applying.

- cannot benefit, if they benefit from funding for the Erasmus+ project, from any other type of EU contribution (including the grants to attend a Double Master's degree) or coming from funds of the University of Camerino, granted to spend a mobility period abroad.

Students undertaking a mobility period may not sit examinations or obtain their degree before the mobility has officially ended and before the Degree Programme Board has validated the academic activities completed at the host institution. This rule also applies to PhD candidates and postgraduate students.

2.3 Language requirements

To apply for the 2026-2027 Erasmus+ grant, the minimum language requirement is B1 level according to the CEFR, acknowledged by the Council of Europe, to be certified according to one of the following modalities:

- a) possession of a language certificate (TOEFL, Cambridge, Cervantes, Delf, Dalf and so on) attesting at least the B-1 level requirement, according to the CEFR;
- b) stays abroad in a country whose official language is the same as the one to be used during mobility, for a period of at least 60 days (also in this case, a certificate attesting the duration and nature of such stay is required);
- c) enrolment in a degree programme entirely taught in English.

For PhD students attending the International School of Advanced Studies (ISAS), it is sufficient to have attended a master's degree programme in English.

The copies of certificates shall be attached to the application.

The language requirements as per the above paragraph are needed to submit an application. It is pointed out anyway that the Partner Universities might require further skills; applicants are therefore advised to verify the language requirements of the university where they intend to spend an Erasmus+ period.

2.4 Available destinations

The list of the available destinations constitutes an integral part of the Call for applications (*Annex 1-Agreements Table*).

The table, divided by Schools, shows the destinations, the language requirements, if any, specific of a certain institution, the number of grants available for each destination and the relating duration, based on the agreements of the two universities, as well as a link to get the information required to organise mobility at best.

Available destinations can be divided into:

- Destinations within Erasmus+ mobility agreements (*Annex Table 1 and Table 1 "United Kingdom and Switzerland Mobility"*);
- Destinations within the "KREATIVEU" Alliance <https://kreativeu.org/>;
- Destinations within Erasmus+ mobility agreements for students enrolled in degree programs with available double degree agreements (*Table 2*).

The requirements set by each Partner University may be subject to change even after the publication of the Call for Applications.

Students can apply for maximum **TWO different destinations**.

When choosing destinations, it is recommended to carefully examine the course catalogue of the Receiving University and evaluate the compatibility with one's own study plan, the linguistic requirements, the application deadlines, and any entry and stay arrangements: these aspects may preclude the departure. As a rule, the host universities set deadlines for:

- **nomination** (receipt of names) of those who will carry out an Erasmus+ mobility, by International Relations Office;

- **application** (admission application) of those who have been indicated in the nominations, by the student.

If the above deadlines are prior to the conclusion of the selection process, the departure in the first semester of the a.y. 2025/2026 is not guaranteed and it will be necessary to consider a possible departure in the second semester, regardless of the number of months foreseen by the exchange. All students are invited to check the nomination/application deadlines and any language requirements before applying by consulting the website of the host university.

2.5 Activities to be performed during mobility and Learning Agreement

Students must indicate, in their online application, the educational activities they intend to carry out during their mobility. This information is merely indicative and does not prevent them from the possibility to include other activities in their official study plan that will be indicated in the Learning Agreement.

The **Learning Agreement** is the document that establishes the study plan to be followed abroad and is mandatory for all mobility students, including PhD students, both for study and for research/thesis preparation. "Table A" must include the programmes to be attended during mobility, "Table B" the programmes which shall be acknowledged by UNICAM upon conclusion of mobility.

The Learning Agreement proposed by students must be approved and undersigned by the Delegate for International Mobility of the relating degree programme and by the receiving university.

The Learning Agreement may be changed within the first month after the student's arrival at the receiving university, but any changes shall be communicated by email to the International Relations Office; the latter will send such request to the Delegate for International Mobility of the degree programme and to the School Manager, who will authorise the requested changes.

The authorisation will be sent to the concerned student by email.

Students are reminded that **the activities allowed** during mobility for study are as follows:

1. educational activities (courses) and corresponding assessment tests (exams);
2. preparation of the degree and/or PhD thesis;
3. combined activity of exams and curricular traineeship (only if provided for by the educational regulations).

For any information related to permitted activities, students may refer to the Delegates for each Degree Course.

2.6 Submission of applications

Each candidate is invited to fill-in the online application at <https://didattica.unicam.it>, available in one's reserved area – International mobility – Outgoing mobility.

Students may indicate maximum TWO different Partner Universities.

The questionnaire included in the application shall indicate the activity that students intend to carry out abroad, i.e., the attendance to programmes to take the relating exams, by specifying which ones they intend to attend, or the preparation of thesis, by indicating the name of one's supervisor.

The application, together with the required attachments, shall be **submitted WITHIN H. 12:00 A.M. OF MARCH 16, 2026**.

To be admitted to the selection:

1. candidates must duly fill-in all the required sections.
2. candidates enrolled in a master's degree programme shall mandatorily declare in their application the bachelor's degree title and final mark achieved in the "*Dichiarazioni aggiuntive*/Additional statements" section of the online form.

3. candidates shall submit the Recognition Proposal (*Annex 2*) indicating the learning activities they intend to attend abroad (please complete one Proposal for each chosen university);
4. candidates shall submit the attachments specific of their area (Thesis Declaration only available for Pharmacy students), as requested by the Call for applications (*Annex 3*).

Annex 2 - Thesis Declaration
 Students who intend to carry out their thesis abroad must attach to the application the thesis declaration — signed by the UNICAM professor who will be the supervisor. The receiving University may be indicated by the professor in case he is the same coordinator for several receiving universities. The student, having to indicate two suitable destinations for carrying out the study period, can attach to the application two declarations from the same professor or from two different professors. A professor can issue the thesis declarations for the same host institution even in a number higher than the actual availability of the receiving university exchanges, since the final ranking will establish who will be assigned to such destination.
- 3- **Only for the International School of Advanced Studies (ISAS) students:**
 Students must fill in the online application and attach the Curriculum Vitae and Presentation Letter of the UNICAM PhD Coordinator.

3. SELECTION PROCEDURES

3.1 Criteria for the creation of lists

The **selection and assessment criteria for the creation of ranking lists** are the same for the students of all the University Schools.

The lists for the University Schools will be drawn up according to the following criteria:

- **academic career:** ratio between the acquired ECTS (exams passed) and the ECTS provided for from the enrolment date until submission of applications (usually, 60 ECTS per year. For students who are not enrolled within the regular duration of their degree programme, the points awarded will be

proportionally reduced based on the number of years exceeding the standard programme length: max 40 points;

- **weighted grade average** (for students enrolled in a master's degree programme, the bachelor's final grade will also be taken into consideration.): max 40 points;
- **language certificate assessment**: max 10 points;
- **study programme assessment** (recognition proposal): max 10 points.

Students shall control the personal data of the online record book to verify in time that all the exams required for the educational activities carried out have been duly recorded.

Students who have obtained a score equal to or greater than **5 points** in the evaluation of the Study Program are considered **eligible** and will therefore be placed in the final rankings.

The Commission will be appointed after the deadline for the submission of applications and will be composed of the Rector's Delegates for International Mobility, the Delegates of the Study Course/School, a contact person from the Office and a member of the International School of Advanced Studies, for the evaluation of the ranking of the Doctoral Students.

The Commission will acquire the opinions of the Delegates of the Study Course/School regarding the applications and, in particular, the evaluation of the Study Program and will draw up the final rankings.

The Commission may also hold his meetings electronically.

It is pointed out that, once the ranking lists have been published, it is essential to abide by the deadlines and comply with the rules for the acceptance of the university assigned to them.

3.2 Acceptance of grants/destinations, waivers, inclusion in the list of incoming candidates

The ranking lists, created per each University School, will be subdivided according to the cycles which students pertain to (bachelor's degree programmes, master's degree programmes and 3rd cycle programmes) and will be available on Unicam website (<https://www.unicam.it/ateneo/bandi>) starting from 30th March, 2026. Based on these lists, the Delegates of each Study Course/School, in agreement with the Delegate for International Mobility, will assign the available destinations to students. A dedicated meeting will be held for each degree programme with the respective Delegates. The meeting dates will be published on the Unicam website (<https://www.unicam.it/eventi>)

After confirming their acceptance, students shall:

- a) define the *Learning Agreement Online* (OLA) for the Erasmus+ mobility period and have it approved, according to the procedures provided for by the Erasmus Office;
- b) abide by the administrative requirements of the Partner University (*Application Form*);
- c) sign a *Financial Agreement*.

The Office will communicate to the Partner University the winners of the selection (nomination phase); at all events, it is the students' duty to get acquainted with the administrative accomplishments and the relating deadlines established by the Partner Universities. Failure to comply with the above, students may run the risk of not being accepted by the Partner University.

Students awarded an Erasmus+ study mobility grant are reminded that admission is ultimately decided by the Receiving University. If the application is refused, the University of Camerino cannot guarantee reinstatement.

3.3 Filling of vacancies with the next-ranking successful candidates of the list

In case of withdrawal, the possible reassignment of the scholarship will be evaluated by the Delegates of the

Study Course/School in agreement with the Delegate for International Mobility, based on the student's career and the remaining destinations.

In such event, they will be informed by mail of the possibility to accept the next-ranking available place.
