Applications must be sent by 1.00 pm CEST (Italian time zone) on 24 July 2026.

APPROXIMATE TIMELINE

The selection procedure comprises the following main steps (timing is purely provisional):

1 – (From the date of publication to 24 July 2026) Call launching – Selection procedure: candidates must submit the Application form through website: <https://pica.cineca.it/unicam/phd42/domande> by **1:00 p.m. (Italian time) on 24 July 2026**. In particular, they must present their identity document, Curriculum vitae, a short hypothetical research project, letters of reference (up to three), a letter of motivation (statement of purpose), and choose, in order of preference, two curricula of the PhD Course of interest among those proposed by UNICAM. A detailed description of each topic will be available in **Annex 1** to the Call; it will be the exclusive responsibility of the candidate to verify any updates to Annex 1 that could be integrated in the event of further funding for the XLII PhD cycle.

Each candidate must submit an application for admission to each PhD course of interest, up to a maximum of 3 applications.

2 – (by August 7, 2026, and in any case in due time for the convocations) Verification of eligibility requirements and evaluation of CVs – UNICAM appoints an Evaluation Committee for the purpose. A shortlist of the candidates who are admitted / admitted “subject to confirmation” to the second stage of the selection procedure is published. The interview calendar is established and published. In the meantime, further eligibility checks may be carried out if necessary.

3 – (From August 24, 2026 onwards) The second phase of the evaluation procedure is carried out: the candidates admitted or admitted "subject to confirmation" will have to undergo remote oral interviews according to the published calendar.

The dates and methods of carrying out the oral tests and any corrections will be published on the website <https://www.unicam.it/ateneo/bandi> and on the page <https://isas.unicam.it> after the closing of the Call. This publication has the value of official notification for all legal purposes; Therefore, the candidates will not receive any personal communication regarding the invitations for the interviews.

4 – (by September 2026) The final merit-based ranking lists are published.

5 – (1 November 2026) Expected start date for PhD programs: November 1, 2026.

Art. 2 POSITIONS AND PHD SCHOLARSHIPS

The following are expected to be funded:

- 6 scholarships in the Architecture, Design, Planning Programme
- 9 scholarships in the Chemical and Pharmaceutical Sciences and Biotechnology Programme
- 4 scholarships in the Computer Science and Mathematics Programme
- 3 scholarships in the Legal and Social Sciences Programme
- 11 scholarships in the Life and Health Sciences Programme
- 5 scholarships in the Physics, Earth and Materials Sciences Programme

The total number of scholarships currently available is **38**.

Based on the rank lists and in the presence of the conditions necessary for their activation, positions without the use of a scholarship may be made available in the order of 1 for every 3 positions with a scholarship.

Drawing from the ranking list of suitable candidates, the University reserves the right to assign other positions. The assignments will be subject to the availability of further funding for the XLII PhD cycle.

Some PhD scholarships/positions are assigned as part of programmes, projects or agreements, including with external bodies. They involve the performance of research on specific topics and bind the assignees to the performance of such research. Specifically, the finalised positions covered by this announcement will be:

- **up to a maximum of 6 supernumerary positions** reserved for Chinese citizens graduated from Zhengzhou University of Light Industry under the agreement signed between the University of Camerino and Zhengzhou University of Light Industry (China), to preferably carry out research on topics of Food Sciences, Chemistry, Biology, and Design;
- **up to a maximum of 5 supernumerary positions** reserved for Chinese citizens graduated from Zhengzhou University of Light Industry under the agreement for the issuing of the double degree signed between the University of Camerino and Zhengzhou University of Light Industry (China), to preferably carry out research on the topics of Food Science and Engineering, Chemical Engineering and Technology, Light Industry Technology and Engineering, Software Engineering, Computer Science and Technology, Art Design, Resources and Environment, Biology and Medicine, Business Administration.
- **1 supernumerary position** reserved for Chinese citizens graduated from Jilin Agricultural University under the agreement signed between the University of Camerino and Jilin Agricultural University (China).
- **up to a maximum of 5 supernumerary positions** reserved for Chinese citizens graduated from Liaocheng University, within the framework of the agreement signed between the University of Camerino and Liaocheng University, to carry out research preferably on topics of Physics, Chemistry, Mathematics, Biology and Veterinary.

Art. 3 COMMITMENTS OF PhD STUDENTS

According to the national law and the current regulation in UNICAM, PhD positions require a full-time commitment, both in terms of training and research activities, and possibly teaching, tutoring and student services. Periods of research and training abroad are foreseen. Additional activities/conditions are also foreseen for specific research topics/scholarships, if included in the specific agreements or in the funding rules of the scholarships and/or positions. Please, read UNICAM Regulations in force for a more in-depth overview.

Without prejudice to the full-time commitment, work activities, including paid ones, concerning practical professional training or limited external work activity that allows the acquisition of skills relating to the formative field of the PhD Programme, are also compatible with the PhD Programme, subject to approval by the Scientific Board of the PhD Programme and authorization by the SAS Board.

Art.4 CAREER, RIGHTS AND DUTIES OF PhD STUDENTS

The rights and responsibilities of PhD students and the requirements for obtaining the degree (“Dottore di ricerca” or “PhD”) are outlined in the UNICAM Regulations for PhD Programmes and the acts issued with Rector's Decree No. 215/2025, available at: <https://www.unicam.it/ateneo/regolamenti> (SECTION “Regulations of general interest”).

Concurrent enrollment in two higher education courses is regulated by Law No. 33/2022 and implementing decrees.

UNICAM and its partners (in case of PhD Programs carried out in partnership with further Institutions) may support non-EU students in finding an accommodation, limited to rooms/apartments that are available in the University college at the time the PhD students arrive in Italy.

Before commencing their activities within their respective PhD programme, PhD candidates must hold valid health insurance coverage, either through registration with the Italian National Health Service (Sistema Sanitario Nazionale - SSN) or via a private insurance policy.

For non-EU PhD candidates: applicants may, independently and at their own expense, register with the National Health Service or, alternatively, take out private insurance policies that meet at least the minimum criteria required by the competent Authorities for the issuance of a post-graduate student visa.

Proof of health/insurance coverage can be provided to the relevant Office, upon request, by submitting a copy of their EHIC (European Health Insurance Card) with a validity period compatible with the PhD programme, or by providing annual receipts of registration/renewal with the National Health Service, or by providing annual receipts of purchase/renewal of a private health insurance policy along with its general terms and conditions.

All PhD candidates benefit from accident and civil liability insurance coverage provided by the University for the entire duration of the programme, solely for activities related to the PhD course, in accordance with the terms offered by the relevant insurance companies.

In the event of an invention made by the PhD candidate within the scope of the university research activity, the University Regulations on intellectual property and patents shall generally apply.

Art. 5 SCHOLARSHIPS AND RESEARCH BUDGET

* **The gross amount of the scholarships** (including taxes paid by the recipient) is approximately €1.353 per month, and approximately **€16.243 per year** (based on a duration of 3 years). Please note that these amounts may slightly vary in the event of any further updates by the National Authorities.

* For all PhD students who are entitled to it under current national legislation, for periods of stay and residence abroad (so-called “mobility abroad”), additional funding is guaranteed corresponding to an increase of no less than 50% of the amount of the scholarship.

* Each PhD student, with or without scholarship or other forms of support, **has a budget for research activity** in Italy or abroad of at least **€4.872,90** during the three-year course and in accordance with the rules established by Italian law, regulations and UNICAM guidelines.

The scholarship is paid to the PhD candidate in monthly installments in arrears (each installment is paid the following month) and only after the enrollment procedure has been fully finalized (for foreign PhD candidates, this occurs only after their arrival in Italy). With regard to PhD candidates enrolled after November 1, 2026, and within the deadlines established by this call, applicable laws, and regulations in force, the payment of the first monthly installment will be deferred accordingly. The payment of the scholarship requires the PhD candidate to hold an Italian Tax Code (Codice Fiscale) and a suitable Italian or online bank account.

The accrual of the scholarships begins on the official start date of the PhD programmes, which is November 1, 2026, unless extensions or deferrals are duly authorized.

In the event that the PhD student arrives later (no later than **30 April 2027**), no installment will be paid before his/her arrival in Italy, nor before the enrollment procedure is completed and an adequate bank account is available.

PhD students can be recipients of a scholarship if the maximum amount of annual emoluments does not exceed the annual amount of the scholarship (gross cost of recipient, currently set by the Ministry at €16.243,00 per year).

For the benefit of the scholarship, PhD students avail themselves of the faculty of self-certification to be referred to the tax period coinciding with the calendar year in which the scholarship is actually paid.

This communication must be sent to the SAS offices (dottorato@unicam.it) no later than 31 July of each year. The university administration may carry out checks on the veracity of the aforementioned self-certifications.

In the event that the annual emoluments of the PhD student with scholarship, during the course of the PhD programme (with the exception of the year of issue of the Call) exceed the annual above-mentioned amount of €16,243.00 of the scholarship net of charges, the PhD student shall forfeit the receipt of the scholarship, with the obligation to repay the amount already received in the reference calendar year. For the purposes of determining the limit of emoluments referred to in the previous paragraphs, the taxable income resulting from certification or tax return deriving from work services is taken into consideration.

Anyone who, even partially, has benefited from a scholarship for a PhD programme, cannot ask to benefit from it a second time.

Scholarships cannot be combined with other scholarships conferred for any reason, except with those granted by national or foreign institutions aimed at supporting stays abroad for the purposes of training or research activity of PhD students.; in the case of scholarships or positions funded under specific programmes or agreements, also in terms of compatibility, the specific rules of the programme or agreement must be taken into account.

Art. 6 FEES FOR ACCESS AND ATTENDANCE TO PhD PROGRAMMES

The annual fees for accessing PhD programs and attending them will be specified in the Manifesto of Studies, available under "University Fees". The Manifesto of Studies will be approved by the Academic Bodies and published on the university's official website.

Candidates who are admitted to the PhD programs are required to pay the regional tax for the right to university study, amounting to €140, as well as a stamp duty of €16, which is paid electronically.

PhD students without a grant who are included in the ERDIS (Regional Body for the Right to University Education) right to study rankings are also exempt from paying the regional tax for the right to university study, which will be subsequently reimbursed, once the existence of the requirements has been verified.

Art. 7 APPLICATION FOR PARTICIPATION IN THE SELECTION PROCEDURE

The application for participation in the selection procedure must be filled out **exclusively** (under penalty of exclusion from the selection procedure/admission) on the format accessible from the website <https://pica.cineca.it/unicam/phd42/domande> by **24 July 2026, at 1:00 p.m. (Italian time)**. Only applications that are submitted within the specified deadline will be considered.

Art.8 FIELDS AND TOPICS

In relation to the Research Fields linked for the a.y. 2026/27 to the PhD Programme and the curricula, specific research themes will be defined for the three-year research projects (topic) to be carried out by the PhD students.

A detailed description of each topic, with any reference to the relevant Research field, will be available in **Annex 1** to the Call; it will be the exclusive responsibility of the candidate to verify any updates to Annex 1, which could be integrated in the event of further funding for the XLII cycle of the PhD programme.

Art. 9 REQUIREMENTS FOR ADMISSION TO THE COMPETITION

In general, Italian and foreign citizens in possession of a specialization/master's degree or similar university qualification recognised as suitable by the academic authorities, on the basis of laws and regulations in force, may submit an application to participate in the competition for admission to PhD Programmes, without discrimination as regards gender, age, religion, nationality, sexual orientation, political opinions, socioeconomic conditions, and disabilities.

Those who will obtain the qualification referred to in the previous paragraph by the date of enrolment in the PhD course can also apply for admission, under penalty of forfeiture of admission to the Programme.

In this case, admission is made "subject to confirmation", and the admission will be made definitive upon communication of the candidate's achievement of the qualification.

Candidates who have obtained the academic qualification abroad must present, for the purposes of enrolment, the Certificate of Comparability and Verification of the foreign university qualification issued by the [centro ENIC-NARIC in Italia \(CIMEA\)](#)² or, alternatively, the Declaration of Value issued by the Italian Embassy in the country where the qualification was issued. The documents must contain all the information necessary for the evaluation of the qualification.

In the Declaration of Value, it must be specified that the qualification that allows access to PhD Programmes on site has been obtained after 17 years of education, and that it satisfies the academic requirements for access to third cycle courses in the issuing country. The Declaration of Value or the CIMEA Comparability and Verification Certificate must be issued, together with the entry visa for Italy, by **31 March 2027** and sent

On the basis of the documentation produced by the candidates, in particular the research project hypothesis, the Selection Committee will carry out its evaluation in accordance with the provisions of the *European Framework for Research Careers* for the R1 profile “*First stage researchers*”, that is:

- ability to conduct original research under the guidance of supervisors;
- ambition to develop knowledge of research-related methodologies and disciplines;
- good knowledge of the research area in which they intend to develop their thesis;
- ability to produce data under the guidance of supervisors;
- critical ability, analysis, evaluation, and synthesis of new and complex ideas;
- ability to illustrate research results and their meaning.

When preparing the short list of suitable candidates, the Selection Committee will also take into account any specific criteria indicated in relation to Research Fields, the candidate’s CV, with particular reference to the degree grade, other qualifications, scientific publications and conference presentations, prizes and awards. Any letters of presentation from the presenters and the statement of purpose will also be evaluated.

At the end of the evaluation process, the Selection Committee prepares the shortlist by Curriculum, if applicable, and subdivided by Research Field, of the eligible candidates admitted or admitted “subject to confirmation” to the second phase of the evaluation procedure, which consists of the interviews.
