**Subject: Selection procedure for the conferral of 5 (five) research collaboration grants financed with PRIN 2022 funds, for the School of Biosciences and Veterinary Medicine (Academic Discipline: BIO/03), School of Pharmaceutical Sciences and Health Products (Academic Discipline: BIO/15), School of Law (Academic Discipline: SECS-P/01,02,06), and School of Architecture and Design (Academic Discipline: ICAR/16) - CALL / NOTICE OF SELECTION PROCEDURE**

### THE RECTOR

**HAVING REGARD TO** Law No. 240 of 30 December 2010, in particular Art. 22 containing provisions regarding “Research Grants”, in force until 29 June 2022;

**HAVING REGARD TO** Decree-Law No. 36 of 30 April 2022, converted with amendments by Law No. 79 of 29 June 2022, published in the Official Gazette – General Series - No. 150 of 29 June 2022, which entered into force on 30 June 2022, containing further urgent measures for the implementation of the National Recovery and Resilience Plan (Italian acronym: PNRR), which in art. 14, paragraph 6-septies introduces research contracts, which will replace research grants, specifying in the following paragraph 6-quaterdecies that it will be possible to continue to launch procedures for the awarding of research grants limited to the resources already programmed or approved by the respective governing bodies until 31 December 2022;

**HAVING REGARD TO** Decree-Law No. 198 of 29 December 2022 (the so-called “Milleproroghe” [one-thousand extensions] decree 2023), converted with amendments by Law No. 14 of 24 February 2023, published in the Official Gazette - General Series – No. 49 of 27 February 2023, which in art. 6, paragraph 1, letter a) modifies the deadline established by law No. 79 of 29 June 2022 to announce the selective procedures for research grants, extending it to 31 December 2023;

**HAVING ACKNOWLEDGED** that, to date, the University of Camerino has never issued procedures for the award of research contracts;

**WITH REFERENCE TO** the Regulation still in force on the Conferral of Research Grants, issued with Rector’s Decree No. 6408 of 07 February 2020;

**HAVING REGARD TO** Ministerial Decree of 9 March 2011, pursuant to Art. 22 of Law No. 240/2010, which established that the minimum amount to be attributed to the holders of research collaboration grants is € 19,367.00;

**HAVING REGARD TO** Ministerial Decrees of 26 February 1999 and of 04 May 1999, respectively concerning identification and reclassification of academic disciplines in university studies, subsequently amended by Ministerial Decree of 04 October 2000;



**HAVING REGARD TO** Law No. 241 of 7 August 1990 and subsequent amendments and additions, containing rules on administrative procedure and the right of access to administrative documents, in compliance with the principles of legality, economy, effectiveness, impartiality and transparency;

## 2) SCHOOL OF BIOSCIENCES AND VETERINARY MEDICINE

**Research Project Title:** “*Italian endemic forest plants: diversity and functional traits of a biological heritage under pressure (FORENDEMICS)*”

**Description of the research project:** Most of the plant diversity resides in the undergrowth of temperate forests, which plays a key role in the functioning of the ecosystem but is often overlooked by management policies. Italian forests are home to many endemic plants about which we have little and incomplete knowledge, ignoring the functional traits that adapt to site conditions and influence the functioning of the ecosystem. Therefore, the impacts of environmental changes on these unique species are unpredictable and can seriously threaten them. The project is based on complementary approaches at the habitat, species, and population levels, considering distribution, size, status, and ecological preferences. Endemic species will be compared with taxonomically close non-endemic ones to identify the extent and direction of functional divergences. The results will inform local policies and forest management strategies aimed at conserving this unique biological heritage of our country.

**Activities to be carried out:** Data acquisition and selection of target species; definition of functional traits and population characteristics; participation in field training and quality assurance procedures; measurements, sampling, analysis in individual populations of the Italian territory. Two seasonal detection campaigns, the collection of propagules, the continuous relationship with the other partners are required. Collaboration in the management and analysis of data and materials will be an integral part of the work.

### 3) SCHOOL OF SCHOOL OF PHARMACEUTICAL SCIENCES AND HEALTH PRODUCTS

**Research Project Title:** “*Extraction and isolation of bioactive secondary metabolites from Carlina acaulis and Acmella oleracea*”

**Description of the research project:** Botanical pesticides, such as essential oils and plant extracts, represent an ecological and sustainable alternative to synthetic pesticides, but their use is often limited by high volatility, rapid oxidation, and degradation due to exposure to air. The choice of botanical pesticides, as well as vectors, is crucial to develop an adequate bio-formulation, capable of acting as a pesticide. In particular, in this project, two natural products with documented insecticidal efficacy were selected as bio-pesticides, namely the essential oil of *Carlina acaulis* (EO) and the extract of *Acmella oleracea* (EX). These two plants will be extracted and their phytocomplex chemically characterized using analytical techniques, such as GC-FID, GC-MS, HPLC-DAD-MS and NMR. Their main bioactive secondary metabolites will be isolated possibly using green methodologies.

**Activities to be carried out:** The grant holder will have to carry out research on the optimisation of extraction and purification processes of bioactive compounds from plants of the Asteraceae family; phytochemical characterisation by GC-FID, GC-MS, HPLC-DAD-MS, NMR; encapsulation of extracts/essential oils/isolated compounds in nano formulations.

#### 4) SCHOOL OF LAW

**Research Project Title:** *“Intangible assets and asymmetries in European value chains: the positioning of Italian companies and sectors”*

**Description of the research project:** The project intends to analyse the role played by intangible assets (patents and other intangible resources) in the distribution of added value, wages, and employment along the European Value Chains (EVCs), and on the contribution and technological positioning of Italian companies and industries in GVCs. On a theoretical level, the project will provide a new conceptual model for the understanding and empirical analysis of the relevance and determinants of the asymmetries of knowledge assets in Europe, examining functional specialisation of employment and distinguishing between the different types of intangible assets. The empirical analysis will use and integrate different bases starting from Inter-Country Input-Output (ICIO) and data on intangible assets provided by the EUKLEMS-INTAN Prod dataset.

**Activities to be carried out:** The grant holder will have to carry out a series of activities, such as the preparation of a data set on inter-sectoral economic and technological flows on a European scale and mapping of the main value chains on a European scale; mapping the levels and dynamics of technological asymmetries in EVCs through an analysis conducted at country and economic sector level; the econometric analysis on the relevance of technological asymmetries in EVCs and the extent

The following shall be admitted to the selection procedure for the conferral of research grants:

- Candidates in possession of a Master's/Specialist Degree or Old-System Degree, or equivalent foreign qualification in the degree class indicated in Article 1 of the Call, or in similar study topics, according to each grants covered by the Call;

- Candidates having a scientific-professional curriculum suitable for carrying out the research activity.

**The aforementioned admission requirements must be met on the expiry date of this call for applications, under penalty of exclusion.**

Foreign citizens must be in possession of a degree equivalent to those previously mentioned. Equivalence must be certified by competent authorities.

Research grants shall not be awarded to permanent staff members at universities, public research and experimentation agencies and institutions, the Italian National Agency for New Technologies, Energy and Sustainable Development (ENEA), the Italian Aerospace Agency (ASI), as well as at the institutions conferring scientific specialisation degrees recognised as equivalent to a PhD degree pursuant to Art. 74, paragraph 4 of Presidential Decree. No. 382 of 11 July 1980.

Candidates excluded from the active political electorate shall not be admitted to the selection procedure.

Foreign citizens must also meet the following requirements:

- a) enjoying full civil and political rights in the Country of origin or provenance;
- b) meeting all the requirements necessary for the Italian citizens, except for the Italian citizenship,
- c) having adequate knowledge of the Italian language.

Pursuant to Art. 18, paragraph 1, letters b) and c) of the Law No. 240/2010 and Art. 1, paragraph 3 of the Regulations, candidates having a degree of kinship or affinity, up to and including the fourth degree, with a Professor working at the School publishing the proposal for the activation of the contract, or with the Rector, Director-General, or a member of the University's Board of Governors, shall not be admitted to the selection procedure.

Furthermore, candidates who have already been awarded research grants by any institution, pursuant to Law No. 240/2010, for a period exceeding 6 years when summed up with the duration of this grant, shall not be admitted to this selection procedure. If the grant has been awarded during a PhD programme without a scholarship and up to the legal duration of the course, that period is not counted.

Furthermore, candidates who have held contracts as research fellows or fixed-term researchers, pursuant to Articles 22 and 24 of Law No. 240/2010, with the University of Camerino or any other



Italian university, government, non-government or online, or with institutions described in Art. 22, paragraph 22 of Law No. 240/2010, for a period exceeding 12 years, when summed up with the duration of this grant, even if not continuous, shall not be admitted to this selection procedure.

Periods spent on maternity leave or sick leave, according to the current legislation, shall not be taken into account for the purposes of the duration of the aforementioned work relationships.

**The Administration may order, at any time, with a motivated provision, the exclusion from the selection procedure due to lack of the prescribed requisites.**

### Art. 3

#### Application and presentation deadline

The application and the related attachments must be submitted exclusively through the computer application system adopted, available at the link indicated on the webpage on which the Notice of the Selectin Procedure was published.

For the online submission of the application, candidates must have an ordinary e-mail address (not certified e-mail), for the purposes of registering with the system. Registration must be done at the time of first access.

#### Art. 4

#### Selection Committee and selection procedure

Each Selection Committee is appointed by Rector's Decree and is made up of the Head of Research Project and two other members, as well as a substitute member, Professors or Researchers, belonging to the academic discipline relating to the project or to the related sector.

If the funds for the disbursement of the grant derive in whole or in part from external funding, a member of the Committee may be an expert, indicated by the funding body, with particular documented competence with respect to the subject of the research program. The external member shall also be subject to the rules of the University's Code of Ethics.



The Committee shall be made known by publishing the nomination decree on the University website, together with the individual names of the Committee members and their curricula.

The selection procedure shall be based on the evaluation of qualifications and publications and can be followed by an interview.

When evaluating the qualifications, the Selection Committee shall consider the doctoral degree or equivalent qualification obtained abroad as a preferential qualification.

When evaluating the qualifications, only publications and specific qualifications relevant to the research activity to be carried out and showing the level of scientific and professional qualification achieved by the candidates will be taken into account.

The interview will focus on topics related to the research project chosen by the candidate and will be aimed at ascertaining the aptitude for research and the professional capacity required for the performance of the tasks to which the selection procedure refers. During the interview, the knowledge of the foreign language requested in the Notice of Competition may also be verified.

At the end of each meeting, the Committee shall draw up a specific report.

At the conclusion of each selection procedure, each Selection Committee, based on the evaluation of qualifications and publications and on the basis of the interview, will define the suitability or otherwise of each candidate and will draw up a ranking list of the suitable candidates.

**With regard to scientific production, each Committee shall also evaluate the degree of creativity and autonomy shown by the candidate.**

In case of renunciation of the successful candidates before the beginning of the activity, or in case of early termination due to unjustified failure to start the research activity, the grants may be conferred to suitable candidates, according to the order of the respective ranking lists.

The grant shall be effective from the first day of the month following the Rector's Decree approving the selection procedure documents, unless there is a subsequent starting date resulting from the programs of the research structure and from agreements between the parties.
