- WITH REFERENCE TO the Resolution of the School of Architecture and Design No. 162 of 3 October 2024, later integrated by the Director's decree, Prot. No. 79157 of 14 October 2024, which defined the groups of academic disciplines, the academic disciplines themselves, the type of scientific and teaching commitment, the implementation of the so-called social impact (the so-called third mission), the number of publications to be presented, and the methods of verification of the foreign language;
- HAVING ACKNOWLEDGED that the new Integrated Plan of Activities and Organisation (*Italian acronym: PIAO*) 2024-2026, approved by the Board of Directors in the meeting of 31 January 2024, as a single programming document, provides for a hiring strategy aimed at restoring the balance between the Teacher/Researcher component and that of the technical-administrative staff, already present in the PIAO 2023-2025, keeping in mind that the University's objective is to restore the ratio of 0.97 situation relating to the year 2012), considering all teachers, except Fixed-Ter Researchers (RTD A), and all permanent technical-administrative staff (so-called strategic indicator);
- WITH REFERENCE TO the resolutions of the Governing Bodies of 13 June 2024, in which the first implementation phase of the planning of the teaching staff and researchers was approved;
- WITH REFERENCE TO the resolutions of the Board of Directors of 24 July 2024, regarding the assignment of staff points to technical-administrative staff, within which, in the introduction, the additional staff points to be assigned to teaching/research staff were identified, deriving from the Extraordinary Plan B (Ministerial Decree no. 795 of 26 June 2023);
- WITH REFERENCE TO the resolutions of the Board of Directors and the Academic Senate of 10 October 2024, in which the activation of the aforementioned call procedures was approved;
- **CONSIDERING** the need to carry out the aforementioned Call selection procedures in the shortest possible time, in order to guarantee the entry into service of the two Associate Professors by 31 December 2024, it is considered appropriate to derogate the provisions contained in art. 3 of the "University Regulations for the discipline of the Selection Procedure for Full and Associate Professors" mentioned above, with reference both to the timing of publication of the announcement, and to the timing of publication of the decree appointing the Selection Committee, and to the deadline for any challenge of the Committee Members, and to the deadline for publication of the evaluation criteria, and to the deadline for the conclusion of the work by the Committee;
- **ASCERTAINED** the financial availability to announce the above-described Associate Professor positions, which will be covered by the resources allocated by Ministerial Decree No. 795 of 26 June 2023 (Extraordinary Plan, called Plan B);

Art. 1 Purpose

Type of research activity:

The scientific activity will consist of research activity on genomics in the field of evolutionary biology and applied to medicine, also on an interdisciplinary scale, with continuous development of bioinformatic techniques and methods for data analysis. The commitment to research also includes collaboration with the "omics" research units operating within the University and at a national level with a focus on international collaboration and planning.

Type of teaching activity:

The teaching activity will include courses delivered in person and in English language by the School of Biosciences and Veterinary Medicine in the three-year, master's or single-cycle degree courses, in reference to biology and biotechnology, with attention to laboratory activities. Supervision of internships and bachelor's/master's degree theses, as well as in the PhD, must be foreseen..

Realisation of the so-called social impact (the so-called third mission):

The third mission activity refers to participation in consolidated activities planned by the University (e.g., Open Houses, Career Days, Science Trips) and to activities related to the dissemination of the results of research in the academic discipline, as per consolidated national and international practices.

Assessment of language skills:

Linguistic skills relating to knowledge of the English language will be assessed on the basis of documented curricular experience (presented international scientific publications, oral communications at international conferences) as per the practice of the scientific community: therefore, assessment in person is not foreseen.

Academic Discipline: CEAR-10/A "Design"

Maximum number of publications to be submitted: 12

Type of research activity:

The candidate must exhibit a high-level scientific profile in the topics related to the academic discipline CEAR-10/A (Design).

The following is requested from the candidate:

- a scientific production, measured on the quality of the products as well as on the intensity and continuity of the work;
- a research activity, developed with interdisciplinary approaches, aimed at intensifying relationships through agreements with public and private bodies in the local area and accessing European funding with the presentation of innovative projects;
- an activity aimed at making the School's courses of study attractive, using the tools provided by the rules and regulations on "quality assurance of courses of study";
- an internationalisation activity, focused on exchanges with foreign universities for teaching and research activities.

The theoretical and experimental research activities will be carried out mainly in the Ascoli Piceno and Camerino headquarters, with applications in case studies at local, regional and international levels.

Type of teaching activity:

The candidate will have to carry out teaching activities within the scope of the already planned study courses, and those being planned; in particular, he/she will carry out his/her duties through theoretical lessons, laboratory activities, training activities provided within the scope of the study courses of the University of Camerino.

Realisation of the so-called social impact (the so-called third mission):

The candidate must demonstrate the ability and commitment to actively contribute to the third mission of the University, promoting the direct application, valorisation, and use of knowledge to contribute to the social, cultural, and economic development of society. This will include participation in scientific dissemination initiatives, technology transfer, and commitment to collaborative activities with public and private entities to promote innovation and development of the territory.

Assessment of language skills:

Linguistic skills relating to knowledge of the English language will be assessed and verified on the basis of the skills that can be seen from the curriculum vitae presented: therefore, in-person assessment is not foreseen.

Art. 2 Publication of the Notice of Competition

This Notice of Competition will be published on the University of Camerino website, at www.unicam.it (including the online noticeboard of the University), on the MUR [Italian Ministry of Education, University and Research] website, at http://bandi.miur.it, and on the European Union website, at http://ec.europa.eu/euraxess.

Announcement of the Notice of Competition will be published in the Official Gazette of the Italian Republic - the 4th Special Series – Competitions and Exams.

Art. 3 Requirements for participation in the selection procedure by Call

Only candidates who, in the three years preceding the deadline of the Call, have not served as a tenured Full Professor, Tenured Associate Professor, Permanent Researcher, or Fixed-term Researcher, as per Article 24, paragraph 3, letters a) and b), or have not held research grants or enrolled in university courses at the University of Camerino or in the Call for mobility as per Article 7, paragraph 5-a, as expressly provided for by Article 18, paragraph 4 of Law No. 240/2010, as expressly provided for by art. 18 paragraph 4 of Law No. 240/2010, as integrated by art. 26 paragraph 2 letter b) of Legislative Decree No. 152 of 6 November 2021 converted with amendments by Law No. 233 of 29 December 2021.

Candidates with the above characteristics may participate in these selection procedures, if they are:

- a. scholars in possession of the National Scientific Qualification, pursuant to art. 16 of Law No. 240/2010, for the recruitment field (now group of academic disciplines) indicated in the Call or for one of the recruitment fields included in the same macro-sector for the roles which are the object of the procedure or for the higher roles, provided that they are not already holders of the same higher roles;
- b. scholars who have obtained the qualification, pursuant to Law No. 210/1998, in the scope and for the range corresponding to those for which the Call is issued, limited to the duration of the same, since pursuant to art. 29 paragraph 8 of Law No. 240/2010, the qualification is equivalent to the Qualification;
- c. Associate Professors already employed at other Universities, classified in the recruitment files (now group of academic disciplines) indicated in the Call;

- b) Candidates excluded from the enjoyment of civil and political rights;
- c) Candidates excluded from the active political electorate and those who have been dismissed or released from a position in Public Administration for consistently insufficient performance, or who have been revoked from another public sector position, pursuant to Art. 127, letter d) of Consolidated Law approved by Presidential Decree No. 3 of 10 January 1957.

Candidates must be in possession of the requirements for admission to the Selection procedure at the date of expiry of the deadline for submitting the application.

Art. 4 Application and presentation deadline

Applications for participation in this selection procedure must be submitted within the peremptory term of **15 days**, starting from the day following the date of publication of the relevant Notice in the Official Gazette of the Italian Republic - the 4th Special Series - Competitions and Exams.

If the deadline for submitting the application falls on a Saturday or a public holiday, the deadline shall be postponed to the first working day.

To participate in the selection procedure, it is necessary to fill in and sign an online application, drawn up according to the model provided by the platform.

The application and the related attachments must be submitted exclusively through the computer application system adopted, available at the link indicated on the webpage on which the Notice of the Selection Procedure was published.

Applications presented in ways other than online will not be considered admissible and therefore will be excluded.

The online compilation and submission of the application must be carried out by 01:00 p.m. (Italian time) on the day of expiry of the Notice.

Each candidate can send only one application.

The following must be attached to the application, in PDF, JPG, JPEG, or PND format (maximum allowed size for single attachment is 5 MB):

- curriculum vitae indicating scientific and teaching activity of the candidate, dated and signed;
- a detailed list of publications submitted, dated and signed;
- a number of publications indicated in Art. 1 of this Notice;
- a copy of a valid identification document (front and back) only if the handwritten signature, without SPID, is used.

Successful application and date of receipt of the application is certified by the computer system by means of a receipt, which will be automatically sent to the e-mail address provided by the candidate during registration.

The computer application system for submitting the application will remain active even on any days when the University is closed.

After the deadline for submitting applications, the system will no longer allow submissions.

Assistance with the online compilation may be requested by sending a specific support request directly from within the platform and will be suspended starting from the twenty-ninth day from publication of the Notice, and until the deadline for the online compilation and submission of the application.

In the application, candidates must declare, assuming full civil, criminal and administrative responsibility, the following:

- 10. To not have been dismissed from a position in Public Administration for consistently insufficient performance, and to not have been revoked from another public sector position, pursuant to Art. 127, letter D, of Consolidated Text of Presidential Decree No. 3 of 10 January 1957;
- 11. The University where the qualification was obtained and the date of approval of the documents (for the subjects referred to in art. 3 letter b) of this Call;
- 12. The indication of the recruitment field in which the National Scientific Qualification was obtained and the date of achievement:
- 13. The indication of the salary class, in the case provided for by art. 3 letter c) of this Call, i.e. in the case of Associate Professors already in service at another University;
- 14. The indication of the position of the same level as that covered by the Call, in the case of scholars permanently engaged abroad in research or teaching activities at university level (hypothesis envisaged in art. 3 letter d);

Art. 5 **Qualifications and Publications**

The candidates must declare in the application the possession of the requirements for admission to the selection procedure, pursuant to Art. 3 of this Notice.

They also must submit the publications deemed useful for this selection procedure.

The number of publications must not exceed the number indicated in Art. 1 of this Notice. If the maximum number of publications is exceeded, the Selection Committee shall evaluate the same, according to the order indicated in the list, up to the limit established. Therefore, the publications sent, but not included in the list attached to the application, shall not be taken into consideration by the Selection Committee.

It is not permitted to refer to documents or publications presented for other procedures to this or another Administration.

The Administration is required to carry out appropriate checks, even randomly, and in all cases where well-founded doubts arise as to the veracity of the statements produced. Anyone making false statements, uttering

forged instruments, or making use of the same, shall be subject to the provisions of Art. 76 of Presidential Decree No. 445/2000.

Acts and documents originally in a foreign language, other than English, French, German r Spanish, must be accompanied by a translation into Italian, certified as conforming to the original, and issued by a competent diplomatic or consular representation, or by an official translator.

Art. 6 **Exclusions**

All candidates shall be admitted to the procedure conditionally, subject to verification of the aforementioned admission requirements. The Administration, with a reasoned provision, may at any time during the procedure exclude those candidates who do not meet these requirements. The exclusion will be communicated directly to the person concerned at the email address indicated during registration on the platform.

Art. 7 General criteria for the evaluation of candidates

The selection is aimed at identifying the candidates most qualified to carry out teaching and scientific tasks, for which the each position has been opened.

The evaluation takes place on the basis of the criteria, and according to the rules set out by the Selection Committee, in line with the indications of the Notice of Competition.

The criteria take into account the qualifications, scientific publications, curriculum vitae, teaching activity, language skills, if required, and specific competences indicated in Art. 1 of the Notice.

Art. 8 Selection Committee and related obligations

For the purposes of the Procedure by Call, referred to in this Notice of Competition, a Selection Committee shall be appointed, composed according to the provisions of Art. 6 of the Regulations, and immediately operational, given the urgency of completing the work.

From the day following the date of publication of the Decree of Appointment on the website and on the official online register, the term of five (5) days for any challenge, if the conditions set out in art. 51 of the Code of Civil Procedure exist, of the Committee Members by the candidates, shall begin.

Committee members are officially required to participate in the work of the Committee, except in cases of force majeure. The renunciation of the appointment or resignation of a member of the Committee, due to unexpected impediments, must be properly justified, and shall take effect only after the issuance of a Decree of approval by the Rector, also appointing a substitute member.

The Committee shall carry out its work in the presence of all members and shall make any decisions by an absolute majority of the same.

The call for the first meeting of the Committee shall be made by the Rector.

In its first meeting, the Committee shall:

2) establish the criteria and the methods for the evaluation of candidates;

At the end of the first meeting, the report containing the criteria and the methods for the evaluation of candidates shall be sent to the Procedure Manager, who must attend to the publication of the same on the University's website, not less than two (2) days before the continuation of the Committee's work.

Each Committee preliminarily verifies possession of the requirements referred to in the art. 3 of this Call, and then proceeds to evaluate the candidate(s) on the basis of the criteria established in the preliminary session.

In all four procedures, the assessment is envisaged without the presence of linguistic skills, according to the methods indicated in the art. 1 of the Call.

At the end of the work, each Selection Committee, after evaluating the candidate(s), carried out on the basis of the scientific publications, curriculum, qualifications, teaching activity and assessment of linguistic skills, with a resolution adopted by a majority of the members, formulates an overall opinion for each candidate, forming a ranking list, and indicating the candidates most qualified to carry out the tasks indicated in the Call.

Once the work is completed, each Committee delivers the competition documents to the person responsible for the proceedings.

The proceedings of the Committee consist of the minutes, drawn up in duplicate copy, of the individual meetings, including the individual, collective and overall judgements expressed on each candidate.

The work of the each Committee must necessarily be concluded by the first week of December 2024.

Art. 9 Approval of the Proceedings

The proceedings must be approved by a Rector's Decree, following the delivery of the minutes by the Committee to the Division of Human Resources, Organisation and Development [Area Persone, Organizzazione e Sviluppo], after verification of their regularity. This Decree shall be communicated to the candidates and to the School publishing the Call, in order to proceed with the subsequent steps.

Rector's Decree approving the proceedings shall be published in the Official Gazette of the Italian Republic, and on the website of the University of Camerino.

From the date of publication of the aforementioned Decree in the Official Gazette, the terms for filing any appeals shall start.

The minutes of the meetings and the individual, collective and overall judgments shall be published on the website of the University of Camerino.

In the event of any irregularities, the Rector shall send the proceedings back to the Committee, together with a substantiated decision, establishing a deadline to provide for any necessary changes.

Art. 10 Call

Following the approval of the documents, each School, based on the outcome of the selection, proposes the call of the Full Professor with a favourable vote of the absolute majority of the first-level Professors.

Without prejudice to the provisions on publication obligations by Legislative Decree No. 33/2013 and subsequent amendments and the Minerva Code, the University of Camerino undertakes to respect the confidential nature of the information provided by the candidate, pursuant to EU Regulation 2016/679.


