Subject: Selective procedure for the award of a research grant that will last from the date of appointment until 27 September 2025 (end date of the PRIN 2022 project), financed by PRIN 2022 funds, for the School of Science and Technology - ssd FIS/03 "Physics of Matter"- Project title: "Transducers and sensors based on opto-electromechanical systems" - Tutor of the research: Prof. David Vitali (D.R Prot.n. 24579 of 03 April 2024) -CALL DEAD LINE EXTENSION

THE RECTOR

HAVING REGARD TO Law No. 240 of 30 December 2010, in particular Art. 22 containing provisions regarding "Research Grants", in force until 29 June 2022.

HAVING REGARD TO Decree-Law No. 36 of 30 April 2022, converted with amendments by Law No. 79 of 29 June 2022, published in the Official Gazette – General Series - No. 150 of 29 June 2022, which entered into force on 30 June 2022, containing further urgent measures for the implementation of the National Recovery and Resilience Plan (Italian acronym: PNRR), which in art. 14, paragraph 6-septies introduces research contracts, which will replace research grants, specifying in the following paragraph 6-quaterdecies that it will be possible to continue to launch procedures for the awarding of research grants limited to the resources already programmed or approved by the respective governing bodies until 31 December 2022;

HAVING REGARD TO Decree-Law No. 198 of 29 December 2022 (the so-called "Milleproroghe" [one-thousand extensions] decree 2023), converted with amendments by Law No. 14 of 24 February 2023, published in the Official Gazette - General Series – No. 49 of 27 February 2023, which in art. 6, paragraph 1, letter a) modifies the deadline established by law No. 79 of 29 June 2022 to announce the selective procedures for research grants, extending it to 31 December 2024;

WITH REFERENCE TO the Regulation still in force on the Conferral of Research Grants, issued with Rector's Decree No. 6408 of 07 February 2020;

HAVING REGARD TO the University of Camerino signing the declaration of commitment to adopt the European Charter for Researchers and of the Code of Conduct for the Recruitment of Researchers, in July 2005.

WITH REFERENCE TO the Gender Equality Plan 2022-2024, under which the University of Camerino guarantees equality and equal opportunities for men and women as regards access to employment and related conditions, including overcoming territorial gaps;

HAVING REGARD TO Law No. 127 of 15 May 1997, in particular article 3 paragraph 7, which provides a preference in favour of the youngest candidate as a preferential element in the recruitment of staff in the event of a tie in scores.







HAVING REGARD TO the Director's Decree No. 104 of 2 February 2022 "PRIN 2022", with which the Call relating to Projects of Significant National Interest for the year 2022 was issued.

HAVING REGARD TO the Director's Decree for admission to financing No. 974 of 30 June 2023, relating to the projects presented by several teachers, including the one presented by Prof. VITALI of the School of Science and Technology.

CONSIDERED the Rectoral Decree Prot. no. 24579 of 03 April 2024, which announced a selective procedure for the award of a research grant that will last from the date of taking up the service until 27 September 2025 (date of conclusion of the PRIN 2022 Project), financed from the PRIN 2022 funds PRIN 2022, for the School of Science and Technology - ssd FIS/03 "Physics of Matter"- Project title project: "Transducers and sensors based on opto-electromechanical systems" - Research Tutor: Prof. David Vitali, published on the University website on 4 April 2024 and whose deadline is scheduled for 6 May 2024;

RECALLING the Decree of the Director of the School of Science and Technology No. 42/2024 of 3 May 2024 requesting an extension of the deadline, if there are no applications participation, so that the procedure would not be deserted.

NOTED that currently no applications have been received;

CONSIDERING the need to ensure maximum participation in the aforesaid procedure by all persons meeting the requirements envisaged in the call for applications, also with a view to the principle of economy of acts;

HAS DECIDED

The extension of the dead line of the notice Prot. no. 24579 of 03 April 2024 by a further 30

days. Therefore, the new deadline is 5 June 2024
